Special Note must be Taken of the Following when Using Epoxy-Resin Compounds:

- The installation of resin compounds requires effective supervision and the employment of skilled operatives. Resin compounds should only be applied by experienced personnel.
- The resin compound must be mixed and applied strictly in accordance with the product instructions and data sheet.
- External installations must be protected from inclement weather and too-rapid drying (direct sunlight, drying winds, etc) during application and curing.
 - High ambient temperatures will considerably shorten the working time of the epoxy.
- Under no circumstances whatsoever should any cleaning agents or compounds other than those recommended be used for cleaning.

Limitations:

- Suitable for joints 2mm 10mm wide.
- Suitable for use with most tiles, However, check for suitability with natural stone products as well as resin-bonded product before commencing with tiling or grouting. Do not use with white or translucent marble tiles.
- Not suitable for installation areas subjected to temperatures exceeding 100°C.
- When used externally, colour variations may occur over time due to UV rays or environmental contaminants.
- Not suitable for use on asbestos-based substrates, dry-wall partitioning or woodenparticle boards.
- Adhesive bed thickness not to exceed 6mm.

Substrate Preparation:

New floor and wall surfaces must be allowed to cure for the minimum periods detailed below to ensure that the tile installation is not compromised by drying shrinkage movement in the substrate:

- New concrete 6 weeks
- New screed 4 weeks
- New brickwork 4 weeks
- New render 2 weeks

TAL Fine Epoxy Mortar & Grout can tolerate a substrate moisture content of up to 5% (75% RH).

Should there be no damp proof membrane below a surface bed or if prevailing moisture levels do not attain 5% or less, it is recommended that **TAL VaporStop HB** (vapour barrier) be applied prior to tiling.

Note: High moisture levels in the substrate will adversely affect the curing and integrity of epoxy-resin compounds. This could easily result in an installation failure.

Any screeding or rendering must be firmly attached to the underlying concrete or brickwork, and the substrate must be of significant strength, structurally sound (no crumbling, cracking, etc) and of a quality and consistency suitable for tiling. All damaged, defective, deteriorated or hollow sounding areas must be removed and made good before proceeding.

The substrate must be clean and free from all traces of surface laitance and contamination such as dust, dirt, waxes, oils, bitumen, old adhesives, paint, grease, weak cement screeds and renders, shutter release and curing agents, sealing compounds, etc. Organic or fungal growth must be removed and the spores killed using an effective fungicide.

The surface must be clean and dry and free of all traces of dust, debris, loose particles and surface contaminants before proceeding.

Priming (When used as an Adhesive):

Porous Surfaces

 Prime the surface with a neat coat of TAL Floor Primer, which is applied by block brush. Allow to dry for 3 – 4 hours, depending on ambient conditions.

Smooth / Dense Surfaces

 Smooth, dense and impervious surfaces do not need to be primed prior to the application of TAL Fine Epoxy Mortar & Grout.

Mixing:

Mechanical mixing is recommended for good mixing and uniform dispersion of product. Incorrect or inadequate mixing will result in non-curing of the epoxy.

Mixing of complete, full Packs is advocated.

There are 2 components to this product – 1. Resin 2. Hardener, both in paste form. If part-mixing is to be done, it is imperative that the **exact** 1:1 mix ratio is used for all mixes.

Empty ALL the contents of the Resin and Hardener containers into the bucket supplied (adding the Resin first, then the Hardener), and mix thoroughly <u>at low speed</u> for 1 minute. Do not overmix, as this will shorten the pot life.

After mixing the product is useable for approximately 1 hour at 20°C, after which time any portion unused must be discarded.

Note:

- The optimum working and curing temperature is 23°C.
- In hot conditions the pot life and working time will be considerably shorter.
- The epoxy will take significantly longer to cure at temperatures below 10°C.
- It is essential not to mix more adhesive kits than can be used within 1 hour.

Application:

Ambient temperatures between 10° C and 25° C must be maintained during application, and for a minimum of 48-72 hours thereafter.

As an Adhesive

The substrate must be completely flat and level as TAL Fine Epoxy Mortar & Grout cannot be built up (packed) to compensate for any variances in levels in the substrate.

Apply the adhesive to the clean, prepared substrate using a Notched Floor Trowel to ensure a solid bed of adhesive of 3 – 5mm thick beneath the tiles.

Never butt-joint tiles. Joints are required to allow the individual tiles to move with respect to each other and thus avoid a compressive stress build-up. They are also required as vents for the adhesive to cure.

We recommend a minimum of 3mm wide between ceramic wall tiles and porcelain tiles, and 5mm wide between ceramic floor tiles. (Refer to tile manufacturer for recommended joint width.)

Bed dry, clean tiles firmly into the wet adhesive with a twisting action to ensure full contact with the adhesive. Tap tiles home well with a rubber mallet or wooden trowel handle. Remove the occasional tile to ensure that good contact has been achieved.

Remove surplus epoxy from the face of the tiles immediately. Clean the face of the tiles by

scrubbing in a circular motion with clean, cold water and a white, non-woven nylon scouring pad.

Remove loosened epoxy residues with a clean sponge.

Note:

- Do not tile over structural, expansion or cold joints in the background. These joints must be extended through the various layers to the surface.
- Ensure that heavy and/or large format tiles on vertical surfaces (resin bonded listellos, bullnosing, step tiles, etc) are well supported by means of a batten or some type of mechanical device until such time that the adhesive has set sufficiently to support the weight of the tile. Allow for 5 - 6 hours, depending on ambient conditions.
- When installing resin-bonded products the grout joints should be a minimum of 5mm wide, and tile panel movement joints should be located at closer centres.
- Correctly Constructed intermediate tile panel movement joints and perimeter joints, minimum 5mm wide, must be located at the required centres. Contact TAL for more detailed information.

As a Grout

Grouting must not commence until the adhesive beneath the tiles has set sufficiently. (Refer to the adhesive instructions for curing times.) Porous and/or unglazed tiles should be sealed with a suitable sealer before grouting to prevent staining.

The joints must be clean and free from water, dust, debris and contaminants. Adjacent tiles must be clean and dry.

Working in small areas at a time, apply TAL Fine Epoxy Mortar & Grout using a rubber grout squeegee or float and rub the grout well into the joints, ensuring that the joints are properly filled and the grout is heavily compacted into the joints by means of steel pointing tool.

Remove excess **TAL Fine Epoxy Mortar & Grout** from the face of the tiles before it starts to set (harden). This can be done by pulling the grout squeegee at a 90° angle across the joint. Clean the grouted area immediately, and before mixing and applying the next kit of **TAL Fine Epoxy Mortar & Grout**.

Do not allow the grout to dry on the face of the tiles.

Due care must be taken when during application and cleaning not to scratch the face of soft glazed tiles, highly polished tiles or glass tiles.

Cleaning After Grouting:

Immediately after grouting, clean using *lightly* dampened sponge (immerse sponge into a bucket of **clean** water, then wring out to remove excess water). Scrub the surface of the tiles in a circular motion.

NB: Special care must be taken not to dislodge or remove the grout from the joints, or to get water into ungrouted joints.

Wipe a clean sponge diagonally across the tile surface to remove the loosened epoxy residues Rinse the cleaning sponges regularly in a bucket of clean, cold water.

During the initial clean, imperfections in the surface of the grout can be smoothed out with a suitable pointing tool.

For best results a final wash should be carried out 15 – 20 minutes after installation.

If needed, a small amount (30ml) of a clear liquid detergent can be added to the bucket of cleaning water (15L).

Using a clean white scouring pad, loosen any residual grout on the tile. Thereafter clean again using the procedures above.

The installation must be inspected the following day to ensure it is completely clean.

Tacky residues can be removed within 24 hours following the procedures above.

Voids in the joints can be filled using freshly mixed material. Ensure thorough compaction into the joint.

Residual dried haze can be removed using a cloth dampened with **TAL Epoxy Cleaning Fluid**, cleaning the cloth regularly in a bucket of clean, soapy water.

TAL Epoxy Cleaning Gel may be required for larger/stubborn residues.

Note:

- Due care must be taken to apply the cleaner to the face of the tile only as it will affect the grout in the joints.
- Greater care and more abrasive scouring pads may be required with some types of tiles, ie those with textured surfaces, unglazed and quarry tiles.

Clean tools immediately with clean, cold water. Dried material should be removed using **TAL Epoxy Cleaning Fluid** or **Gel**.

Drying & Curing Times:

- Newly applied or cleaned installations must not be trafficked until the grout has set sufficiently (minimum 24 hours for light foot traffic, and minimum 48 hours for heavy traffic) to ensure that the grout is not dislodged or damaged. Dirt may become embedded in uncured epoxy.
- The installation must be suitably protected for a minimum of 7 days after installation. The hardness of the grout should be checked after 3 days.
- TAL Fine Epoxy Mortar & Grout must be allowed to cure for a minimum of 7 days before exposure to chemicals, and a minimum of 10 before water submersion (swimming pools).

Temperature Resistance :

TAL Fine Epoxy Mortar & Grout will withstand service temperatures within the range of -30°C up to 50°C for prolonged periods, and up to 100°C for short periods.

Coverage:

Adhesive

Approximately 4kg/m² when applied in a solid bed of 4mm thickness.

NB: The above coverages are indicated as a guide for ordering purposes only. Actual coverages will be determined by site conditions, workmanship, etc.

Grout

Use the following formula to estimate the grout coverage:

 $(A + B) \times C \times D \times E$

(A x B)

A = Tile Length (mm)

B = Tile Width (mm)

C = Tile Thickness (mm)

D = Joint Width (mm)

E = SG of TAL Grout (1.8)

All measurements MUST be in mm, and this will give the grout coverage in kg/m².

Always add 10% for wastage.

Maintenance Cleaning:

Allow to cure for **minimum 3 days** before routine cleaning.

Use a neutral Ph cleaner, followed by rinsing with clean water.

Do not use Organic or Mineral Acid compounds for cleaning.

Packaging:

Available in 5kg buckets.

Storage & Shelf Life:

When stored in **original**, **sealed packaging** in dry internal conditions between 10°C and 30°C and out of direct sunlight the product has a shelf life of 6 months from date of manufacture. **Never store directly on a concrete floor**.
